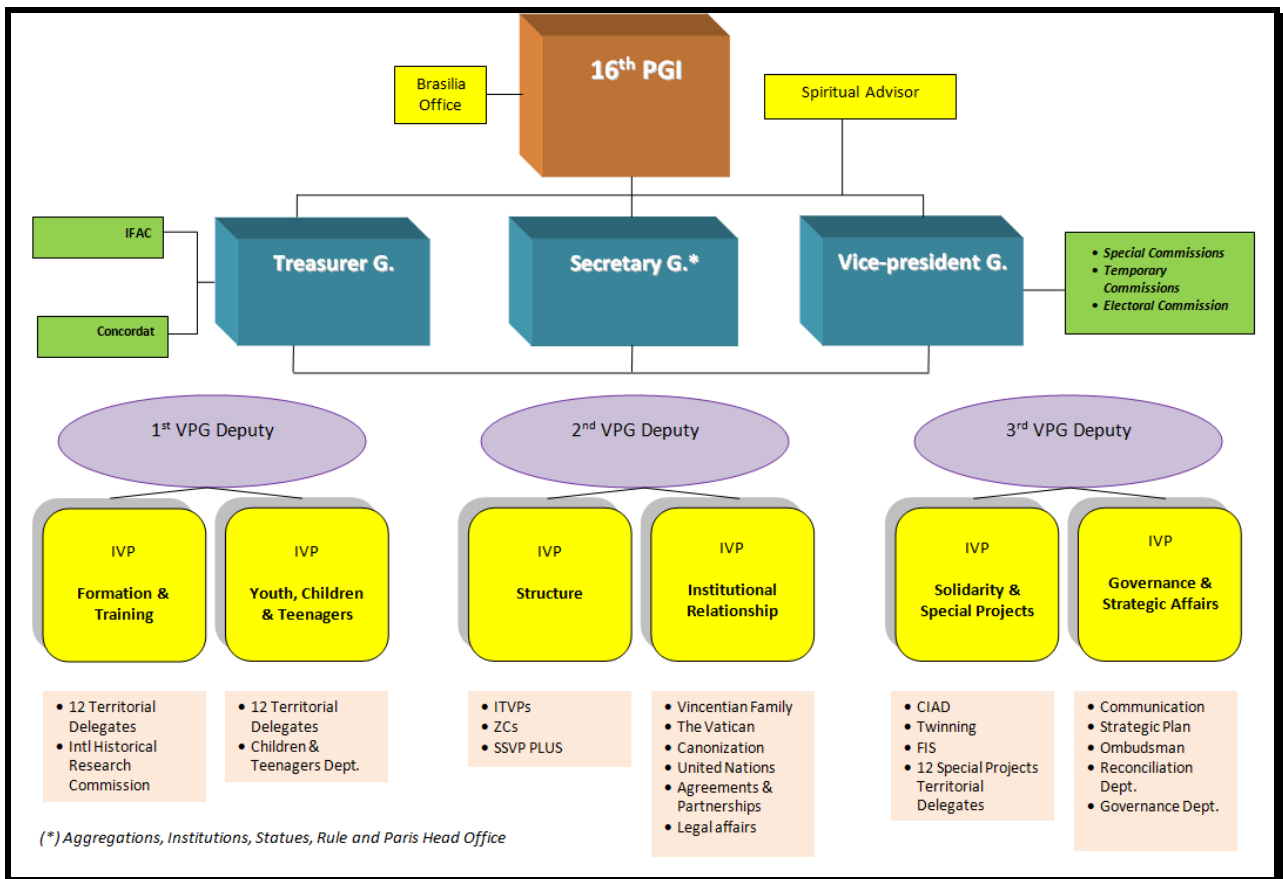




## TO THE INTERNATIONAL SOCIETY OF SAINT VINCENT DE PAUL
